Cookie Policy

1 PURPOSE

- 1.1 Cookies are small text files that are placed on your computer by websites that you visit. They are widely used to make websites work, or work more efficiently by remembering your preferences, recording what you have put in your shopping basket, and counting the number of people looking at a website. They can provide information to the owners of the site. Most web browsers allow some control of most cookies through browser settings.
- 1.2 By continuing to use our website, you consent to the use of cookies (including third-party cookies) as described in this policy.
- 1.3 Details about the cookies we use are set out below. Some of these are third party cookies – see the section on third-party cookies below for more information.
- 1.4 The rules on cookies are covered by the Privacy and Electronic Communications Regulations 2003 (PECR). PECR also covers the use of similar technologies for storing or accessing information, such as 'Flash cookies' and device fingerprinting.

2 SCOPE

- 2.1 This policy applies to all of the Weston College Group websites.

3 HOW CAN I CONTROL MY COOKIES?

- 3.1 You can use your web browser's cookie settings to determine how our website uses cookies. If you do not want our website to store cookies on your computer or device you should set your web browser to refuse cookies. However, please note that doing this may affect how our website functions. Some services may become unavailable to you.

Browser Controls

- 3.2 You can use your web browser to:
 - delete all cookies;
 - block all cookies;
 - allow all cookies;
 - block 'third-party' cookies (ie, cookies set by online services other than the one you are visiting);
 - clear all cookies when you close the browser;
 - open a 'private browsing' / 'incognito' session, which allows you to browse the web without recording your browsing history or storing local data such as cookies (you should however be aware of the limitations of this feature in a privacy context); and
 - install add-ons and plugins that extend browser functionality.

4 TYPES OF COOKIES

4.1 We categorise cookies based on the reasons we use them, these include

4.2 **Strictly Necessary**

These cookies are essential for our websites to perform their basic functions. These include those required to allow registered users to authenticate and perform account related functions, as well as to save the contents of virtual "carts" on sites that have e-commerce functionality.

4.3 **Preferences**

These cookies are used to store preferences set by users such as account name, language, and location.

4.4 **Statistics**

Performance cookies collect information on how users interact with our websites, including what pages are visited most, as well as other analytical data. We use these details to improve how our websites function and to understand how users interact with them.

4.5 **Marketing**

Marketing cookies are used to track visitors across websites. The intention is to display ads that are relevant and engaging for the individual user and thereby more valuable for publishers and third-party advertisers.

5 THIRD-PARTY COOKIES

5.1 Our websites make use of different third-party services to enhance the experience of website visitors.

5.2 We use third-party cookies from social media and media streaming platforms to enable functionality such as like & share buttons.

5.3 Third-party cookies are used by providers to track your online activity.

5.4 Weston College have no direct control over the information that is collected by third-party cookies.

Purpose: This cookie is used to recognize the visitors using live chat at different times in order to optimize the chat-box functionality.
Expiry: Past
Type: Third-party

Provider: promonitor.weston.ac.uk
Purpose: General purpose platform session cookie, used by sites written with Microsoft .NET based technologies. Usually used to maintain an anonymised user session by the server.
Expiry: Session
Type: First-party

Name: __RequestVerificationToken
Provider: applications.weston.ac.uk
Purpose: This is an anti-forgery cookie set by web applications built using ASP.NET MVC technologies. It is designed to stop unauthorised posting of content to a website, known as Cross-Site Request Forgery. It holds no information about the user and is destroyed on closing the browser.

Purpose: This cookie is set by Google Analytics. It stores and update a unique value for each page visited and is used to count and track pageviews.

Purpose: This cookie name is associated with Google Universal Analytics, according to documentation it is used to throttle the request rate - limiting the collection of data on high traffic sites.

Purpose: Facebook sets this cookie to show relevant advertisements to users by tracking user behaviour across the web, on sites that have Facebook pixel or Facebook social plugin.
